The Mobility Committee Meeting commenced at 10:30 a.m. on Tuesday, September 3, 2019.

The next meeting was set for Tuesday, May 19, 2020 in The Woodlands, Texas.

1. Introduction of Committee Members and Meeting Attendees

Discussion: The meeting began with an introduction of committee members and attendees. A

quorum was established by the presence of Committee Chair from The Woodlands Township, Chairman of the Board of Directors for The Woodlands Township, Gordy Bunch; Vice Chair of the Committee from the City of Conroe, City Council Member Seth Gibson; and Alternate Committee Member - Other Providers from the City of Shenandoah, City Administrator Kathie Reyer. Other attendees (sign-in sheet attached) were invited to introduce themselves and their organizations. No representative was in attendance from Montgomery County.

Action: No formal action needed.

2. Consider an Update Regarding Progress for Appointing the Committee and Alternate Representatives for "Other Providers" – **Action Item** (3 minutes)

Discussion: Ms. Ruthanne Haut, The Woodlands Township, gave a briefing on this matter.

The Mobility Committee nominated Mayor Ritch Wheeler of the City of Shenandoah as the committee member and City Administrator Kathie Reyer of the City of Shenandoah as the alternate committee member for Other Providers. Resolutions of support have been received from City of Shenandoah, City of Willis, and the City of Oak Ridge North. Concurrence is pending from City of Panorama Village, City of Cut and Shoot, and the Town of Woodloch. With a 50/50 split, Ms. Haut recommended that the Committee accept the appointees

nominated.

County Engineer Mark Mooney, alternate to Commissioner James Metts for Montgomery County, recently retired from Montgomery County. Mr. Gordy Dynah advised that the garles amont of the Alternate for the County.

Bunch advised that the replacement of the Alternate for the County Commissioner be someone that is willing to attend the Mobility Committee. As a

voting member of the Houston-Galveston Area Council, it is important that the Commissioner and/or his staff is informed of ongoing mobility efforts in the area. Mr. Robert McHaney, The Goodman Corporation, will reach out to Montgomery County to coordinate the nomination of an alternate to Commissioner James Metts. Said nomination will be brought back to the next Mobility Committee

meeting.

for Other Providers were approved by Motion carried.

5. Consider a Discussion to Establish Dates for future Conroe-The Woodlands UZA Mobility Committee Semi-Annual Meetings

Discussion: Mr. Robert McHaney, The Goodman Corporation, presented recommendation to

change Conroe-The Woodlands UZA Mobility Committee quarterly meetings into semi-annual meetings. Mr. McHaney recommended to meet on May 19, 2020. A November 2020 meeting will not be scheduled due no actions required; however, a meeting date could be scheduled for December or January if there are any action

items pending.

Action: Recommendation that the Conroe-The Woodlands UZA Mobility Committee

meets semi-annually instead of quarterly and next meeting's date (May 19, 2020)

were approved as presented.

6. Consider Discussion and a Resolution of Support to Revise the Program Management Plan for Conroe-The Woodlands UZA FTA Section 5310 Program, Enhanced Mobility of Seniors and Individuals with Disabilities

Discussion: Ms. Susan Maclay, The Goodman Corporation, provided a briefing about the

revision of the Program Management Plan for Conroe-The Woodlands UZA FTA Section 5310 Program that would allow City of Conroe to award funds at their discretion if criteria is met instead of having to go through a call-for-project or competitive process. Per Federal Transit Administration guidance, the City can award funds at their discretion as long as the recipient meets 3 criteria: 1) adherence to Title VI, 2) program is reflected in regional coordination plan, and 3)

adherence to Title VI, 2) program is reflected in regional coordination plan, and the service is not a duplication of services. The revision to the PMP would be permanent, though it is anticipated that a competitive process will be held for

FY2018, FY2019, and FY2020 funds.

carried.

7. Consider Presentation, Public Comment and a Resolution of Support for the City of Conroe to Execute a Contract with Meals On Wheels of Montgomery County for FY2017 Conroe-The Woodlands UZA FTA Section 5310 Program, Enhanced Mobility of Seniors and Individuals with Disabilities, Funding

Discussion: Ms. Maclay, provided a briefing about the recommendation to award FY2017

Conroe-The Woodlands UZA FTA Section 5310 Program funds (\$155,364) to Meals on Wheels of Montgomery County. Ten percent of funds (roughly \$17,000) will be programmed for the City of Conroe to administer the program. Like the previous grants, funds will be used for purchase of services (taxi voucher

program) and for preventative maintenance of vehicles.

No public comments were made

applicants with limited funds.

Discussion: a. City of Conroe: Ms. Shawn Johnson, City of Conroe, presented the Conroe

Connection Ridership Summary for the Third Quarter Federal FY2019 (April 1, 2019 through June 30, 2019). Regarding the Conroe Commuter Connection (new Park and Ride service), ridership has been steadily increasing. Currently, City of Conroe is heavily marketing the service in order to increase passenger load to the

fifty percent goal.

b. The Woodlands Township: Ms. Ruthanne Haut, The Woodlands Township, presented the Woodlands Quarterly Ridership Report for the Second Quarter Calendar Year 2019 (1 April 2019 – 30 June 2019). User adoption of the mobile ticketing application for The Woodlands Express and Town Center Trolley is growing. Other improvements to the Trolley service include the installation of

stop annunciators and the trolley tracker app.

c. Meals On Wheels Montgomery County: Ms. Elizabeth Barlow, Meals on Wheels Montgomery County, presented the report for the Senior Rides. A drop in unlinked passenger trips was noticeable from the third quarter FY 2018 to third

quarter of FY 2019.

WHEREAS, Meals On Wheels of Montgomery County has an approved Title VI of the Civil Rights of 1964 policy; and

WHEREAS, Meals On Wheels of Montgomery County's project is included in the Gulf Coast Region Updated and approved Regional Coordinated Transportation Plan and serves a documented public transportation need; and

WHEREAS, the Designated Recipient has posted a public notice and requested public comment including an opportunity to comment during the Conroe-The Woodlands UZA Mobility Committee meeting; and

WHEREAS, the Designated Recipient proposes to execute a contract with Meals On Wheels of Montgomery County for purchase of service and

preventative maintenances in the amount of \$155,364 from the Conroe-The Woodlands Section 5310 Program.

Agenda Item 4

ACTION ITEM – Consider and approve Resolution in support of awarding FY18, FY19, & FY20 Section 5310 Program, Enhanced Mobility of Seniors and Individuals with Disabilities Funds – (10 minutes)

Background

The City of Conroe (City) is the Designated Recipient (Administrator) for Conroe-The Woodlands UZA Section 5310 Program, Enhanced Mobility of Seniors and Individuals with Disabilities. The Federal Transit Administration (FTA) apportions approximately \$170,000 per Fiscal Year to the UZA.

The Designated Recipient (DR) is responsible for choosing the method for project selection. The DR may use a formula for allocation, impose its own limitations on use of the funds, use a competitive project selection process, or use an entirely discretionary selection process. The City issued a call-for-projects on March 12 and held virtual public meetings on March 18 and March 19 to take comment on the needs of seniors and individuals with disabilities, discuss the funding program, and the application process. There were two members of the public that attended these meetings: a staff member from Meals on Wheels Montgomery County and Dr. Brenda LeVar from NAMI Greater Houston. The DR also received a notification of interest from Bridgewood Farms (Enid Goodman) but did not to submit an application.

Applications

The DR received an application from Meals On Wheels of Montgomery County for \$360,000 (federal) from the Conroe-The Woodlands Section 5310 Program funds for purchase of service (\$180,000) and preventative maintenance (\$180,000) (Attachment 1), which was characterized by the DR as a capital project and an eligible expense under Section 5310. The project also:

- (1) Assures equity of distribution of benefits among eligible groups within the UZA, as required by Title VI of the Civil Rights Act of 1964, and as demonstrated by Meals On Wheels of Montgomery County's Title VI policy; and
- (2) Is included in a locally developed and approved coordinated plan, which included seniors and persons with disabilities, as demonstrated in the Gulf Coast Region Regional Coordinated Transportation Plan (RTCP).

Public Comments

The City will notify the public about the proposed award in the Conroe Courier and on the City's web site. The City will open the public comment period on May 18, 2020, with the publication in the Courier (Attachment 2). The comment period will close on June 11, 2020. The City will consider all comments received during the comment period and publish any changes to the award in the Conroe Courier and on the City's web site. The public notice in the Conroe Courier and on the City's web site also notified the public about the opportunity for public comment during the June 11 Conroe City Council meeting.

SECTION 1-PROJECT DESCRIPTION

Meals on Wheels of Montgomery County. Senior Rides is the only non-profit 501(c) 3 in Montgomery County that is solely dedicated to promoting health and independence for aging adults that face physical challenges with transportation and food services.

The Transportation program is operated with a fleet of 5 vehicles, all of which are wheelchair accessible. The organization provides an average of 1,250 trips per month across the county, which includes travel to and from medical appointments, activity centers, grocery stores, essential errand destinations, such as pharmacies or the social security office. Many of the clients served are solely reliant on this service because they do not have the income necessary to pay for private transportation or have available family members to help them get to these critical appointments and life-enhancing activities.

The agency has a long history of sustained service and works every year to further diversify funding sources and increase local support for long term sustainability. The agency operates extremely efficiently and was recognized as the most efficient provider for demand-response service by the newly created Conroe- Woodlands Urbanized Area Designated dual-recipients. Senior Rides per trip cost is also several dollars less than the national average for Demand & Response providers, as reported by the National Transit Database.

The program is constantly seeking new opportunities to partner and innovate to increase transportation in the county, and thus has a wide network of support in the county, both politically and financially, partnering with local government entities, elected officials, business leaders, social service agencies, and for-profit transportation providers.

Senior Rides benefits from a diverse funding portfolio which includes many local sources that will allow the agency to best leverage FTA 5310 funds, including: The City of Conroe, The Woodlands Township, Montgomery County United Way, Montgomery County Community Development Block Grant, Houston-Galveston Area Council Area Agency on Aging, Montgomery County and several private and corporate donors.

SECTION 2-PROJECT PERFORMANCE

PART I:

Senior Rides is requesting 2 eligible capital purchases with the available 5310 funds: Preventative Maintenance and Purchase of Service. These are critical funding requests in order to maintain current services, improve service quality, and plan for continuation of service.

Preventative maintenance funding allows the agency to ensure that it is properly managing its rolling stock and getting the best use of these federally funded assets. The agency has an excellent relationship with several maintenance vendors, who offers excellent pricing for quality service to keep the fleet on the road in good repair.

Purchase of Service funding allows the agency to improve efficiency by using smaller vehicles subcontracted by a third party to complete some of the trips in the outlying areas of the UZA, thereby enabling Senior Rides to maintain better levels of services within the UZA. It also allows the agency to offer more subscription type trips, such as dialysis three times a week, than it could perform with just the fleet of buses alone.

PART II:

Gaps in Service Filled: Within the UZA boundaries, Senior Rides is the only Demand & Response service available for seniors and individuals with disabilities. In January 2015, the City of Conroe launched Conroe Connection, which is its first local public transportation fixed route. This addition to the county is useful for seniors and people with disabilities to get to their most frequently needed destinations and compliments Senior Rides Transportation service. The transportation program is an essential community service that is relied upon heavily by the people it serves, who are isolated and homebound without it, even within the Urbanized Area.

Ridership: The agency expects to provide approximately 16,800 trips in the UZA in the next fiscal year, with the addition of the Purchase of Service funds requested. Senior Rides prides itself on its ability to work efficiently with the limited resources it has to meet as much demand as possible.

SECTION 3-DEMONSTRATED NEED FOR CAPITAL ASSISTANCE

The agency continues to operate an aging fleet for several years now, the maintenance on which continues to rise with each passing year. Over the past few years, the agency has partnered with new maintenance vendors who provides us with excellent reliable service, low cost pricing and great customer service. Our current average monthly repair and maintenance cost is \$2,500 compared to last year's cost of \$3,000.

Preventative Maintenance funding is vital to extending the, life of the current vehicles as long as possible, which is a critical component to providing long-term, reliable, and consistent service to seniors and individuals with disabilities. Preventative Maintenance ensures issues are caught preemptively and prior to developing into a safety hazard.

The Purchase of Service funding allows Senior Rides to be in more places at one time. Currently, we are at capacity for subscription trips, which are weekly reoccurring reservations. The Purchase of Service contract is an economically efficient way to expand our services and fleet to accommodate for more trips in the area.

The dispatch office receives between 50 and 60 new client requests from people who have never used the service each month. Currently, referrals to our service are based on word of mouth from the other social service agencies in the county. Declined trips are between 20-30 trips each month, however that only reflects trips the agency turns down from clients already being served. Based on population estimates Senior Rides is only scratching the surface of the potential riders in the area. The agency is more than willing to plan for expansion of services in the long term, because the need is there and Senior Rides is the largest Demand & Response provider in the area. However, the first priority for the agency is to get its fleet healthy, and then plan for a gradual and sustainable expansion to meet more of the rapidly growing demand.

SECTION 4-PROJECT OVERSIGHT AND MANAGEMENT

Senior Rides is the provider of the greatest number of demand-response trips for senior adult and disabled residents of Montgomery County. As such, the agency is experienced in managing an efficient transportation program. Senior Rides continuously updates program policies and practices to ensure best practices are used. The agency's Dispatch Supervisor and Compliance Director trains agency drivers on customer service, safety standards, and elderly and disabled client sensitivity. Senior Rides has developed a close working relationship with its new maintenance vendors, who are aware of Senior Rides maintenance plan and works with the agency to ensure proper maintenance is completed at the lowest possible competitive price. Senior Rides maintenance plan is included in this application as an attachment.

As the only organization dedicated to serving senior adults in Montgomery County, Senior Rides manages a diverse funding portfolio for each agency program. Since 1973, the agency has professionally and responsibly administered services using local, state, and federal grant funding, serving as a good steward of awarded funds.

In response to changes in the availability of federal and state funding, Senior Rides has focused on the further- diversification of funding in order to maintain program availability. The agency has also increased community outreach to ensure county residents are informed of the service availability. This outreach has resulted in additional individual funding support for the Transportation Program. In May 2015, the agency finalized its rebranding effects changing the name to Meals on Wheels Montgomery County - Senior Rides. The goal of these efforts is to gradually reduce reliance on state and federal funding for program operation.

Senior Rides benefits from an experienced staff leadership team, Board of Directors, and Finance Committee comprised of a diverse group of professional community members who provide oversight and their expertise concerning financial and programmatic matters. This network of support serves as a secondary assurance to funders that grant guidelines and program goals are closely followed.

SECTION 5-LOCAL SUPPORT AND COORDINATION

Senior Rides is entering its eighth year of a successful financial partnership and contract agreement with each of the Conroe-The Woodlands UZA Designated Recipients to provide limited eligibility Demand & Response transportation service. The agency provides the Designated Recipients a quarterly report on its services including trip numbers, hours of service, revenue miles, and detailed trip data that includes passenger type, trip purpose, origin and destination, service complaints, and vehicle breakdowns. At each quarterly public meeting of the UZA Transit Advisory Committee, the agency provides a quarterly update on the service and answers any questions from the Committee members and members of the public.

The agency participates in the Regional Transportation Coordination Subcommittee in an effort to coordinate its services with the region at large. Locally, the agency works with many different social service providers to ensure better access to the transportation program and to eliminate potential duplication of services.

The Montgomery County Transit Plan states "seniors, disabled and low income individuals that live within Montgomery County are mobility limited. They have very few viable travel options...Parts of the county are urbanizing very quickly, while other parts are retaining their rural character...A significant population exists in the County who by reason of age, income, and/ or physical disabilities require additional transportation options for daily life needs such as medical, education, grocery and shopping. Senior Rides provides efficient transportation services county wide, despite this extreme duality between the urban and rural nature of the program's service area.

ACTION ITEM – Consider and approve the FY2020 Conroe-The Woodlands UZA FTA Urbanized Area Formula Sub-apportionments for Section 5307 and 5339 Programs (15 minutes).

Background

On June 4th, 2019, The House of Representatives approved the fiscal year 2020 Consolidated Omnibus Appropriations bill, the legislation that provides discretionary funding for the federal government for the current fiscal year. The bill provides \$12.7 billion in total budgetary resources for the Federal Transit Administration (FTA). Subsequently, the FTA published the apportionments for FY 2020 for the Conroe-The Woodlands Urbanized Area.

The FTA full year apportionment of Section 5307 and Section 5339 funds enable Conroe and The Woodlands to accurately sub-apportion FY 2020 funds based on a formula comprising of population, population density, and transit system performance. The full year sub-apportionments are shown in Table 1 and 2 with previous years apportionments for comparison.

Section 5307: The FY 2020 Section 5307 Apportionment is approximately \$60,877 more than the FY 2019 apportionment (Table 1).

MEMORANDUM OF UNDERSTANDING BY AND BETWEEN CITY OF CONROE

AND

THEWOODLANDS TOWNSHIP

This Memorandum of Understanding (MOU) is entered into between the City of Conroe (the "City"), Texas, a home rule municipality, and The Woodlands Township (the "Township"), a political subdivision of the State of Texas duly created and operating pursuant to Chapter 289, Acts of the 73rd Texas Legislature, Regular Session, 1993, as amended, for the purpose of continuing, facilitating and enhancing public transit programs and services ("Transit Programs") within the Conroe – The Woodlands Urbanized Area ("UZA") and, more specifically the subarea allocation of FY 2019 Section 5307, Urbanized Area Formula Program, for ADA complementary paratransit service.

WITNESSETH

WHEREAS, the City and Township are dual "designated recipients" for the receipt of federal formula funding for the Conroe – The Woodlands Urbanized (UZA) area; and,

WHEREAS, on October 1, 2012, the City and the Township entered into an Interlocal Agreement ("Original Agreement") regarding ongoing federal and state funded Transit Programs that became part of the UZA; and

WHEREAS, on October 23, 2017, the City and the Township entered into a First Amendment to extend the expiration date of the Original Agreement to October 1, 2022; and

WHEREAS, on May 19th, 2020, the City and Township entered into a Second Amendment regarding the ADA Subarea Allocation of up to ten (10) percent of the annual apportionment of FTA Section 5307 formula funding approved for the Conroe – The Woodlands UZA; and,

WHEREAS, FTA Circular 9030.1E, Urbanized Area Formula Program: Program Guidance and Application Instructions, states recipients operating fixed route systems may use up to ten (10) percent of their annual formula apportionment under FTA Section 5307, at the capital project 80/20 federal/local share ratio, to pay for ADA complementary paratransit services in accordance with 49 CFR part 37, Subpart F, for grant recipients that are in compliance with U.S. DOT regulations at 49 CFR parts 27, 37, and 38 implementing the transportation provisions of the Americans with Disabilities Act of 1990 (ADA); and

WHEREAS, the allocation may be based on the proportionate share of ADA operating expense for the City and the Township, the proportionate split of FTA Section 5307 and/or as negotiated between the City and the Township, which must be agreed to in writing between the City and the Township by separate instrument; and,

WHEREAS, the City proposes a subarea allocation of the ten (10) percent of available FY 2020 Section 5307 federal formula funding in accordance with **Table 1** attached as Exhibit A to this MOU.

ARTICLE 1 FY 2020 SUBAREA ALLOCATION OF FTA SECTION 5307 FOR ADA PARATRANSIT SERVICE

The City and Township have agreed to determine on an annual basis, the proportionate share of FTA Section 5307 formula funding which can be used to support 80% of eligible ADA paratransit operating costs in accordance with FTA provisions. For FY 2020 the City and Township agree that the City may use up to \$336,717 which is a 100 percent of the available cap under FY 2020 FTA Section 5307 funding, to support up to 80% of the City's Cost to provide ADA paratransit service.

ARTICLE 2 REPORTING

The City agrees to report operating cost, revenue, revenue miles and unlinked passenger trips for its' FY 2020 ADA paratransit service to the Township report within forty-five (45) days following the start of FY 2021. This data can be used to determine the subarea allocation of FY 2021 FTA Section 5307 for ADA paratransit service.

ARTICLE 3 NOTIFICATION TO FTA

The City and Township agree that it will be the responsibility of the City to notify the FTA of the subarea allocation of FY 2020 Section 5307 for ADA complementary paratransit service.

ARTICLE 4 TERM OF MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding will be in effect for thirty-six (36) months from the date of execution by the City and the Township, and may be extended by mutual written agreement of the parties by providing sixty (60) day notice of one party to the other of the intention to extend the agreement.

ARTICLE 5 LIABILITY AND INDEMNIFICATION

The Parties agree that no individual Party will be liable to the other for any acts of negligence of the employees, agents, or subcontractors engaged to support completion of the activities described within this MOU; and, the parties agree that they will mutually indemnify each other for the actions of their employees, agents, or subcontractors engaged to support completion of the activities described within this MOU, to the extent permitted under the laws of the State of Texas.

The parties agree that their respective employees shall continue to be their own, and no party will claim that an employee of one entity has acted as a borrowed servant of the other.

Complementary Paratransit Service

This memo reviews the FTA policy allowing recipients to reimburse themselves at the 80 percent capital rate for Americans with Disabilities Act (ADA) complementary paratransit (paratransit) operating expense; and the application of that policy within the Conroe-The Woodlands UZA. The UZA is limited by the FTA to program ten (10) percent of its apportionment for complementary paratransit service to be reimbursed at the 80 percent capital rate (Attachment A: FTA Policy on use of Capital Rate of Reimbursement for Complementary Paratransit Service Operating Expense).

The City initiated ADA complementary paratransit service in January 2015. The City initially reimbursed itself for ADA service with Job Access Reverse Commute Funds and the Section 5307 provision for Capital Cost of Contracting. Beginning with the FY 2015 Section 5307 sub-apportionment, the City programmed funds under the ADA complementary paratransit capital rate provision (Table 1). As the ADA complementary paratransit service expands, the City projects an increasing use of the capital rate provision.

Recipients operating fixed route systems may use up to 10 percent of their annual formula apportionment (the 10 percent applies to annual formula apportionments under Sections 5307 and 5311), at the capital project 80/20 federal/local share ratio, to pay for complementary paratransit services in accordance with 49 CFR part 37, Subpart F, for grant recipients that are in compliance with U.S. DOT regulations at 49 CFR parts 27, 37, and 38 implementing the transportation provisions of the Americans with Disabilities Act of 1990 (ADA). IV–10 FTA C 9030.1E DATE 1/16/2014
- (1) ADA Compliance: Eligibility for using this expanded definition of capital depends on compliance with ADA requirements. FTA recipients must certify compliance with the ADA annually, and are subject to compliance review activities conducted by FTA to monitor compliance and correct deficiencies. Entities whose compliance is in question, due to volume of complaints, compliance review findings, or triennial review findings, will be subject to review and approval prior to using capital funds to operate ADA paratransit service.
- (2) UZAs with More than One Recipient: When a UZA has more than one recipient, it is the designated recipient's responsibility to work with public transportation operators to allocate the 10 percent of the UZA's apportionment that may be used for ADA paratransit purposes. Recipients' subarea allocation documentation should include language regarding the use of the ADA paratransit provision.

INFORMATIONAL ITEM – Update on the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) Conroe-The Woodlands UZA FTA Section 5307 Urbanized Area Formula Program Sub apportionment.

Background

The Coronavirus Aid, Relief, and Economic Security (CARES) Act was passed by Congress and signed into law by President Trump on March 27, 2020. The bill allocates \$25 billion for "Transit Infrastructure Grants to prevent, prepare for, and respond to coronavirus. The funds are appropriated...as if such funds were provided under section 5307 of title 49, USC...in the same ratio as funds were provided in the fiscal year 2020 appropriations." This means that relative to the nationwide allocation, using the FY20 5307 formula results in the Conroe – The Woodlands Urbanized Area receiving \$9,538,252.

These funds, generally referred to by the Federal Transit Administration (FTA) as "CARES Act funds," are provided over and above the annual and regularly anticipated federal formula apportionments authorized by the FAST Act, are sourced from the general fund, and are made available as an emergency requirement, pursuant to the Balanced Budget and Emergency Deficit Control Act of 1985. There are several special conditions related to the expenditure of the CARES Act funds which make them unique from standard FTA 5307 formula funding; these conditions include, but are not limited to the following:

- Funds remain available until expended.
- No local match requirement (funds are 100% federal).
- Federal planning requirements (POP/STIP/TIP) are waived for certain expenditures

The Interlocal Agreement between the City of Conroe and The Woodlands Township allows for a separate written agreement to determine how these funds are allocated, otherwise known as a "split" letter, which is independent to the CARES Act Transit Infrastructure Grant funds. This split letter must be submitted to the FTA for either agency to apply for, receive, and disburse grant funds. This funding split will be determined by the designated recipients, with advice and consultation from the Mobility Committee.

For an additional amount for "Transit Infrastructure Grants", \$25,000,000,000, to remain available until expended, to prevent, prepare for, and respond to coronavirus: Provided, That the Secretary of Transportation shall provide funds appropriated under this heading in this Act as if such funds were provided under section 5307 of title 49, United States Code, and section 5311 of title 49, United States Code and apportion such funds in accordance with section 5336 of such title (other than subsections (h)(1) and (h)(4)), section 5331 (other than subsection (b)(3) and (c)(1)(A)), section 5337 and section 5340 of title 49, United States Code, and apportion such funds in accordance with such sections except that funds apportioned under section 5337 shall be added to funds apportioned under 5307 for administration under 5307: Provided further, That the Secretary shall allocate the amounts provided in the preceding proviso under sections 5307, 5311, 5337, and 5340 of title 49, United States Code, among such sections in the same ratio as funds were provided in the fiscal year 2020 appropriations: Provided further, That funds apportioned under this heading in this Act shall be apportioned using the fiscal year 2020 approtionment formulas: Provided further, That not more than three-quarters of 1 percent, but not to exceed \$75,000,000, of the funds for transit infrastructure grants provided under this heading in this Act shall be available for administrative expenses and ongoing program management oversight as authorized under sections 5334 and 5338(f)(2) of title 49, United States Code, and shall be in addition to any other appropriations for such purpose: Provided further, That notwithstanding subsection (a)(1) or (b) of section 5307 of title 49, United States Code, funds provided under this heading are available for the operating expenses of transit agencies related to the response to a coronavirus public health emergency and lost revenue due to the coronavirus public health emergency, including the purchase of person

to reductions in service: Provided further, That such operating expenses are not required to be included in a transportation improvement program, long-range transportation, statewide transportation plan, or a statewide transportation improvement program: Provided further, That the Secretary shall not waive the requirements of section 5333 of title 49, United States Code, for funds appropriated under this heading in this Act or for funds previously made available under section 5307 of title 49, United States Code, or sections 5311, 5337, or 5340 of such title as a result of the coronavirus: Provided further, That unless otherwise specified, applicable requirements under chapter 53 of title 49, United States Code, shall apply to funding made available under this heading in this Act, except that the Federal share of the costs for which any grant is made under this heading in this Act shall be, at the option of the recipient, up to 100 percent: Provided further, That the amount made available under this heading in this Act shall be derived from the general fund and shall not be subject to any limitation on obligations for transit programs set forth in any Act: Provided further, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 251(b)(2)(A)(i) of the Balanced Budget and Emergency Deficit Control Act of 1985.

INFORMATIONAL ITEM –Process for Filling the Alternate Representative position for The Woodlands Township due to retirement of Don Norrell

Background

According to the adopted Bylaws of the UZA Mobility Committee:

"MEMBERSHIP AND TERMS OF OFFICE: Appointments shall be approved by a body of elected officials representing each interest, such as city council, governing board or commissioners' court. There is no limitation on the number of terms each appointee may serve, however the body of elected officials must appoint their Advisory Committee members annually except for the initial appointment, which will expire December 31, 2014. The primary appointees must be an elected official of the entity he or she represents. The alternate appointee may be an elected official or an employee of the entity. If a member of the Committee chooses to resign, the represented entity shall appoint a new representative to the Committee in a timely manner. A Committee member cannot be removed by the Committee before the end of a scheduled term; however, changes of Committee members by the appointing body of elected officials may be made at any time. One Committee member shall be appointed by each of the following interests.

- The Woodlands Township
- City of Conroe
- Montgomery County
- Other Providers

Each Advisory Committee member may have a designated alternate member who may serve at any Committee meeting in the regular member's absence. Alternate members must be appointed in the same manner as the regular member. Appointed alternate members will have the voting rights and privileges of regular members when serving in the absence of the regular member."

Current Situation

Alternate Committee Member Don Norrell, President/General Manager of The Woodlands Township has announced his retirement. As a result, The Woodlands Township will need to appointment a new alternate representative, effective for the November 2020 UZA Mobility Committee meeting.
